Next audit of SIMAC Training

The audit team will recommend that the future frequency of the inspections/audits of the VTS courses at SIMAC Training may be considered to be 5 years provided that SIMAC Training continue to:

- carry out internal audits at least once a year, and
- the Quality Management System (QMS) and the Training Management System (TMS) are maintained and updated including the qualification and experience of the instructors.
